

**“MOVIES FOR FOOD” SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE, SUBSCRIPTION OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE, SUBSCRIPTION OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. OPEN ONLY TO LEGAL RESIDENTS OF THE 49 CONTIGUOUS UNITED STATES AND D.C. (EXCLUDING RESIDENTS OF NY AND FL) WHO ARE 18 YEARS OF AGE OR OLDER AND THE AGE OF MAJORITY IN THE STATE THEY RESIDE AT THE TIME OF ENTRY AND ARE CHARTER COMMUNICATIONS CUSTOMERS AS OF OCTOBER 31, 2011. VOID WHERE PROHIBITED.

1. **ELIGIBILITY:** The “Movies For Food” Sweepstakes (the “Sweepstakes”) is open only to legal residents of the forty-eight (48) contiguous United States and the District of Columbia, (excluding residents of NY and FL), who are 18 years or older and the age of majority in the state they reside at the time of entry and are Charter Communications Customers as of October 31, 2011. You need not be present to win. Employees of Charter Communications Operating, LLC (the “Sponsor”), Sponsor’s advertising, marketing and promotion agencies, Stampede Fulfillment and More, Inc., and each of their respective parents, subsidiaries and affiliated companies or divisions (all of the foregoing, the “Sweepstakes Entities”), and such employees’ immediate family members (spouse, parent, child, sibling) and household members, are not eligible.  - 1) To enter online, visit charter.com/movies and follow the directions provided to complete the entry form during the Entry Period. Provided you have complied fully with these Official Rules, you will receive one (1) entry into the drawing. Limit one (1) per person and per email address. Online entries must be received by Sponsor by 11:59 p.m. CT on January 4, 2012. Each online entrant must be the registered subscriber or authorized user of the email account by which the entry is made. In the event of a dispute as to entries submitted by multiple users having the same e-mail account, the authorized subscriber of the e-mail account (as specified by the Internet Service provider) used to enter the Sweepstakes at the actual time of entry will be deemed the entrant. Entries made by an individual or any entity other than the named entrant and/or originating at any other Internet Website, including (but not limited to) commercial sweepstakes subscription notification and/or entering services, are void. Entries generated by script, macro or other automated or mechanical means and entries by any means which subvert the entry process are void.

 - 2) To enter by mail, handprint your first and last name, date of birth, address, city, state, zip code, e-mail address (optional) and phone number (including area code)

on a 3" x 5" card and mail it in an envelope with proper postage affixed to: **Movies For Food Sweepstakes**, P.O. Box 3398 Littleton, CO 80161-3398. There is a limit of one (1) entry per envelope. Each mailed entry must be postmarked by January 4, 2012 and received by January 11, 2012 in order to be eligible. Proof of depositing entry in mail is not considered proof of delivery or receipt. Entries will not be accepted from post office boxes.

Any service unavailable will not be awarded (ARV: \$3,200.00); One (1) First Prize which consists of a one (1) year subscription to Charter TV in Digital with HD, one (1) HD box, Internet Express with speed up to 12 MB, and Charter Phone with unlimited calling and wire maintenance. All awarded services may not be available in all areas. Any service unavailable will not be awarded (ARV: \$1580.00); and one (1) Second Prize which consists of one (1) gift card (retailer determined at Sponsor's discretion) with a face value of \$100 (ARV: \$100). All prize details (including, without limitation, specific features cable services) will be determined by Sponsor in its discretion. All services are subject to Sponsor's standard terms and conditions. In the event a potential First Prize winner does not live in an area where all awarded services are provided by the Sponsor, that portion of the prize will not be awarded and the Sponsor will have no further obligation to the winner with respect to that prize component.
